POLICY ON PREVENTION OF CIRCULATION OF UNAUTHORIZED INFORMATION BY STAFF

BACKGROUND

Pursuant to the SEBI Circular CIR/ISD/1/2011 dated March 23, 2011 issued circular on restriction on transmitting'unauthenticated news' by stock brokering house and other SEBI registered intermediaries on blogs, chat forums, messenger sites in an effort to prevent stock manipulation through unverified news and roumers. Intermediaries need to have proper internal controls and ensure that proper checks andbalances are in place to govern the conduct of their employees to prevent speculativenews and rumors. The move follows growing concerns over some employees indulginginto activities like fraud against the clients, front-running, circular trading andmanipulating stock prices through rumor mongering. Market rumors can doconsiderable damage to the normal functioning and behavior of the market and distortthe price discovery mechanisms. Broking houses will also have to ensure that anymarket-related news received by their employees, either in their official or personalmail, should be forwarded to clients only after the same has been approved by itscompliance officer.

MEANING

- Company : Company means 'Madhuvan Securities Private Limited'

- Unauthenticated news:Unauthenticated News means information which are notestablished or confirmed from reliable sources. The claims made by or about the subjectmay or may not be true.
- Blogs :Blogs are a type of website or part of a website wherein regular entries of commentary, descriptions of events, or other material such as graphics or video etc. aremaintained and discussed in an interactive way

Chat Forum: Chat forums or message board, is an online discussion site wherepeople can hold conversations in the form of posted messages

Communication Channels:Communication Channels means a channel, whetherelectronic orotherwise, used to convey anymarketrelated information. For example,telephone/mobile phones, SMS, MMS, Blogs, Chat Forums, Messenger sites, SocialNetworking Sites and such other channels as may from time to time be used.

REPORTING:

Employee of the Company is obliged to promptly furnish any market relatenew s/information received by him from an unverified source/communicationchannel to the Compliance Officer of the Company and shall forward the same only after he same has been approved by the Compliance Officer.

PROHIBATION

The Company implements code of conduct for communicating various modes of communication. Company's Director, Employee, Officers, Temporary Staffvoluntary workers and employees are prohibited from;

- 1. Circulation of unauthenticated news related to various Scrips in blogs/chatforums/e-mail etc.
- 2. Encouraging or circulating rumors or unverified information obtained from client, industry, any trade or any other sources without verification.
- 3. Either forwarding any market related news received in their official mail/personalmail/blog or in any other manner except after the same has been seen and approved by the Compliance Officer.
